- May 30 —Office Closed Memorial Day
- Last business day of May—June quarterly installment bills mailed
- On or before June 1—Tax certificate sale for delinquent real estate taxes
- June—Renew company-owned motor vehicles 5,000 lbs. and under.
- June— Renew ½ year registrations of trucks over 5,000 lbs. and truck tractors
- June— 1st installment payment due for the current year real estate and tangible tax
- Last business day of June—Business tax renewal notices mailed
